Program Service Accomplishments Housing Programs - The Center provides emergency shelter through short hotel stays, short term transitional emergency placement (STEP) at our 14-bed youth shelter for 18-24-year-old LGBTQ+ youth experiencing homelessness. We also offer a 6-bed transitional living program for 18-24-year-old youth victims of crime. Both programs provide intensive case management, prevention, and wrap-around services. In total 5,471 bed nights were provided, impacting the lives of 90 18-24-year-old youths in 2024. Youth and Adult Programs - The Center supports LGBTQ+ youth ages 13-24 with affirming programs and services, serving approximately 420 youth in 2024. Our Q-Spot Youth Center offers a 7-day community space to engage with other LGBTQ+ and allied peers and supports their post-secondary and/or collegiate academic success and professional development. Program youth receive mental health respite services, mentorship, and peer support groups.

Program Service Accomplishments Advocacy - The Center is an advocate for equity and social justice within and externally to the LGBTQ+ community, acknowledging that identities of LGBTQ+ people are intersectional by breaking down systems of oppression that harm the most marginalized amongst us. We work to increase visibility, understanding, and access to services for LGBTQ+ people throughout the Sacramento region through individual advocacy and legal assistance, public policy and community organizing, outreach and training. In partnership with our Economic Justice Program that develops LGBTQ+ friendly employers' recruitment and retention pipelines for prospective employees, the Center supported 125 public policy changes, trained 25 organizations reaching 687 individuals, and reached 5,489 people through outreach-based community engagement. Additionally, the Center's Economic Justice

Program hosted 3 job fairs reaching 473 job seekers and 78 employers.
